ARTICLES OF ORGANIZATION
OF
SOUTHWEST CAPITAL, LLC.
A FLORIDA LIMITED LIABILITY COMPANY

The undersigned (the "Member") acting as the organizer of Southwest Capital, LLC under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

ARTICLE 1
NAME

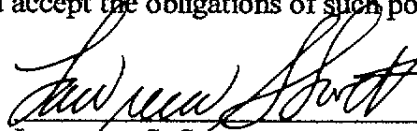
