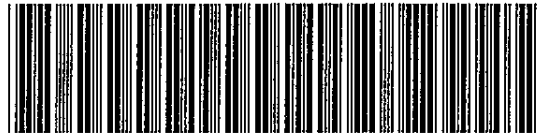

**ARTICLES OF ORGANIZATION  
OF  
SDR Enterprises, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes and files the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be SDR Enterprises, L.L.C. (hereinafter referred to as the "Company").

**ARTICLE II -- ADDRESS**

The mailing address and street address of the principal office of the Company shall be 2900 South U.S. 1, Ft. Pierce, Florida 34981.

**ARTICLE III -- DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization.

**ARTICLE IV -- REGISTERED OFFICE AND AGENT**

The name and street address of the registered agent of the Company in the State of Florida shall be David L. Hancock, Esq. 817 Beachland Boulevard, Vero Beach, Florida 32963.

**ARTICLE V -- CAPITAL CONTRIBUTIONS**

The members of the Company shall each initially contribute to the capital of the Company in cash or in other property agreeable to all the members equal to the number of membership units purchased by the members.

## ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the Company only on the unanimous consent of all the members. In the event the Company has three or more members, each member shall make additional capital contributions to the Company only on the consent of a majority of all the members

## ARTICLE VII -- ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the operating agreement or regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company, other than the member proposing to dispose of his or her interest, approve of the proposed transfer by unanimous written consent.

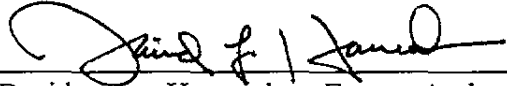
## ARTICLE VIII -- TERMINATION OF EXISTENCE

The Company may be dissolved on the death, bankruptcy, or dissolution of a member or on the occurrence of any other event that terminates the continued membership of a member in the Company unless the business of the Company is continued by the consent of all the remaining members.

## ARTICLE IX -- MANAGEMENT

The Company shall be managed by the members in accordance with the operating agreement or regulations adopted by the members for the management of the business and affairs of the Company. The operating agreement or regulations may contain any provision for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.

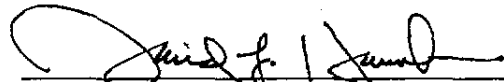
