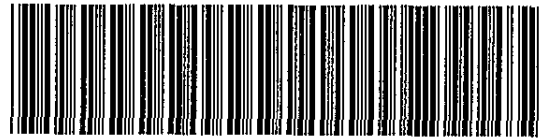

FIRST: The name of said limited liability company shall be

SECOND: MDSPAS @ SECRETS, LLC shall exist in perpetuity.
