ARTICLE I

Name

Continuance of Business

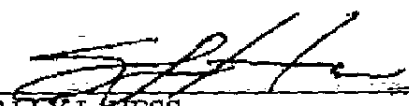

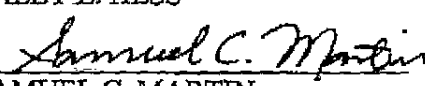
ARTICLE VIII

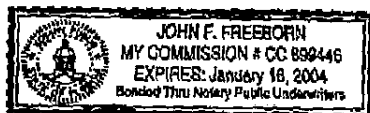
