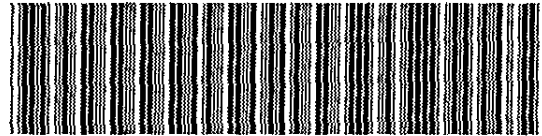

**ARTICLES OF ORGANIZATION OF
ARLINGTON RIDGE LLC**
