ARTICLES OF ORGANIZATION OF HODGE & SUN GETAWAY, L.L.C.

The undersigned acting as organizer of HODGE & SUN GETAWAY, L.L.C., under the Florida Limited Liability Company Act, adopt the following Articles of Organization for said limited liability company.

ARTICLE I
