

AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF MAITLAND TITLE, LLC

ARTICLE I

The name of this limited liability company (the "Company") is hereby changed to City Centre Title, LLC and its mailing address 55 E. Pine Street, Orlando, Florida 32801, and the principal place of business of the company shall be located at 55 E. Pine Street, Orlando, Florida 32801.

ARTICLE II

COMMENCEMENT OF COMPANY EXISTENCE

This Company shall commence existence on the date of signing these articles of organization and shall have perpetual existence unless sooner dissolved according to law.

ARTICLE III

GENERAL PURPOSE: GENERAL POWERS

In the event of the death, retirement, resignation, bankruptcy, expulsion or dissolution of a Member or the occurrence of any event which terminates the continued membership of a Member of the Company, the remaining Members may continue the business of the Company as provided in the Operating Agreement of the Company.

ARTICLE IX

<u>AMENDMENT</u>

The Company reserves the right to amend or repeal any provisions contained in these articles of organization or any amendment hereto, and any right conferred upon the Membes is subject to this reservation.

ARTICLE X

HEADINGS AND CAPTIONS

The headings or captions of these various articles of organization are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various articles shall not be influenced by any of said headings or captions.


