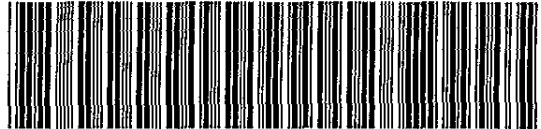

2. **Address.** The mailing address and street address of the principal office of the Limited Liability Company is 2142 NW 20th Street, Miami, FL. 33142.


3. **Registered Agent, Registered Office.** Michael H. Male, 3250 Mary Street, Suite # 303, Miami, Florida 33133.
