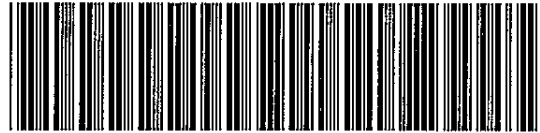

**ARTICLES OF ORGANIZATION OF
HR Orlando, LLC**

ARTICLE I – Name:

The name of the Limited Liability Company is: HR Orlando, LLC (the “Company”).
