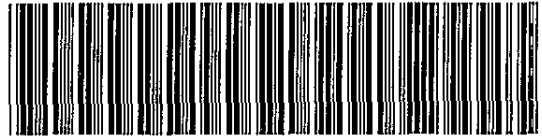

LIMITED POWER OF ATTORNEY

SECRETARY OF STATE




