

ARTICLES OF ORGANIZATION

OF

LOUIS PAPPAS MARKET CAFÉ - BBD, LLC

I hereby file these Articles of Organization as the authorized representative of the member of the limited liability company to be formed pursuant to these Articles of Organization and the laws of the State of Florida.

ARTICLE I

NAME

The name of the limited liability company to be formed hereunder is "LOUIS PAPPAS MARKET CAFÉ - BBD, LLC" (the "Company").

ARTICLE II

DATE OF EXISTENCE AND PERIOD OF DURATION

The Company shall begin existence effective the 21st day of November, 2002, and shall continue until terminated in accordance with the Regulations and Operating Agreement adopted by the member (the "Operating Agreement").






