These Articles, may be amended at any time by a vote of the managing member and such amendment shall be filed with the Florida Department of State.

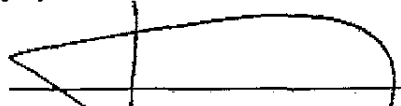
Article IX

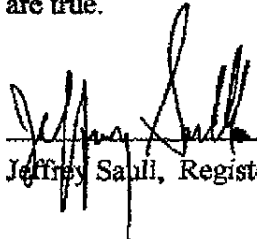
