**ARTICLES OF ORGANIZATION
FOR
TALLEN ENTERTAINMENT, LLC**

ARTICLE 1 – Name. The name of the limited liability company shall be Tallen Entertainment, LLC.

ARTICLE 2 – Address of Principal Office. The mailing address and principal office of the limited liability company shall be 4056 Middlebrook Road, Suite 1321, Orlando, Florida 32811.


ARTICLE 3 – Registered Office and Registered Agent. The name and the Florida street address of the initial registered agent is Philip K. Calandrino, P.A., 7232 Sand Lake Road, Suite 201, Orlando, Florida 32819.

ARTICLE 4 – Management. Initially, one manager shall manage the limited liability company. Therefore, it is a manager-managed company. The manager shall receive a salary for such services and may serve as manager until his or her resignation or removal for cause as determined by a majority vote of the members. The operating agreement for the company may modify the number of managers for the company and their respective terms.

ARTICLE 5 – Membership. The company may issue certificates to indicate ownership in the company; with one percentage of ownership interest equating to one membership unit for a total of 100 membership units. No change of membership in the company may occur without the unanimous consent of all then-existing members and the manager.

ARTICLE 6 – Effective Date. The effective date of the limited liability company shall be November 15, 2002.


