ARTICLES OF ORGANIZATION OF TRIESTE 905, LLC

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies as follows:

ARTICLE I

NAME

The name of the limited liability company shall be **Trieste 905, LLC** (the "Company").

ARTICLE II
