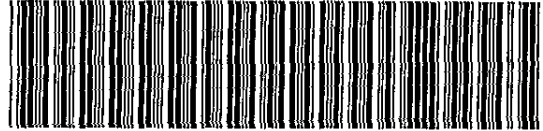

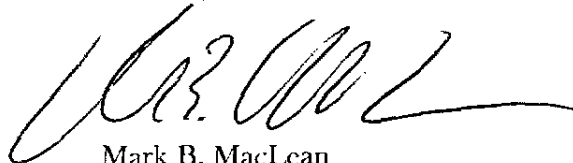

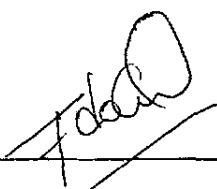
**ARTICLE V**
