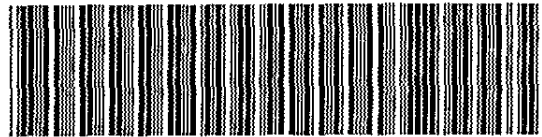

**ARTICLES OF ORGANIZATION  
OF  
KLEER1 MULTIMEDIA, MICHIGAN, LLC**

The undersigned, being the Members and Organizers of the Limited Liability Company hereby being formed under the Chapter 608 of the Florida Statutes, do hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

Kleer1 Multimedia, Michigan, LLC

SECOND: The Limited Liability Company shall continue until the occurrence of an event set forth in the Operating Agreement which causes the termination of the Limited Liability Company.

THIRD: The Limited Liability Company is organized for the following purposes: to own and operate a BullsEye Telecommunications Branchise(ie-franchise) business in the greater Ann Arbor, Michigan area and to carry on any other activities necessary to, in connection with or incidental to the foregoing, as the Managing Member in its discretion may deem desirable.
