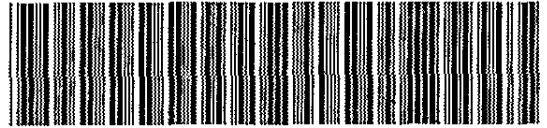

**ARTICLE I  
NAME**

The name of the Limited Liability Company is ScribeCenter, L.L.C.
