ARTICLES OF ORGANIZATION FOR

ARTICLE I. NAME.

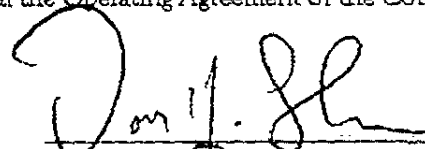

ARTICLE VI. OPERATING AGREEMENT.

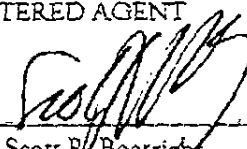
The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Members of the Company.
