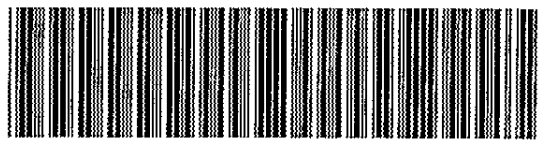

**ARTICLES OF ORGANIZATION  
FOR  
LARNEL P. SULTAN, D.O., PLLC**

**ARTICLE I – NAME**

The name of this professional limited liability company (PLLC) shall be LARNEL P. SULTAN, D.O., PLLC.

**ARTICLE II – DURATION**

The duration of the PLLC shall be perpetual and in accordance with Chapter 608, Florida Statutes, as amended from time to time.

**ARTICLE III – PURPOSE**

The PLLC is organized for the purpose of transacting any and all lawful business under Chapter 608, Florida Statutes, as amended from time to time.

**ARTICLE IV – ADDRESS**

The initial principal office and mailing address of the PLLC shall be 4900 95<sup>th</sup> Avenue North, Pinellas Park, FL 33782. The PLLC reserves the privilege of having branch or other offices at places within or without the State of Florida.

**ARTICLE V – INITIAL REGISTERED AGENT**

The name of the initial registered agent of the PLLC is LARNEL P. SULTAN, D. O. The street address of the initial registered office of the PLLC for service of process shall be 4900 95<sup>th</sup> Avenue North, Pinellas Park, FL 33782.

**ARTICLE VI – PROFESSIONAL/ MEDICAL SERVICES**

The PLLC is formed for the purpose of providing medical services to the public and therefore no member may be permitted to sell or transfer ownership interest in this PLLC except to another professional corporation, professional LLC, or


**ARTICLE VII – POWERS**

The PLLC reserves the rights to amend, alter, change, or repeal any provision or provisions contained in these Articles of Organization, or any amendments thereto.




