**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF  
MCGARVEY CUSTOM HOMES, LLC**

The undersigned, for the purpose of amending the Articles of Organization of MCGARVEY CUSTOM HOMES, LLC, a Florida limited liability company, hereby makes, acknowledges, and files the following amendment to its Articles of Organization, pursuant to Section 608.411, Florida Statutes.

**FIRST:** The Articles of Organization of MCGARVEY CUSTOM HOMES, LLC, were filed with the Florida Department of State on November 27, 2002, and were assigned Document Number L02000031950.


**SECOND:** The following amendment to the Articles of Organization was adopted by MCGARVEY CUSTOM HOMES, LLC:

Article 5 of the Articles of Organization is hereby amended by deleting the existing Article 5 in its entirety and replacing it with the following:

**Article 5: MANAGEMENT**

The Company shall be a manager-managed company and shall be managed by at least one Manager who may, but need not, be a Member, in accordance with the operating agreement adopted by the Members for the management of the business and affairs of the Company (the "Operating Agreement"). The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with the law or these Articles of Organization. At the time that these Articles of Amendment to Articles of Organization are executed, the Managers of the Company are John S. McGarvey and William G. Price, Jr.
