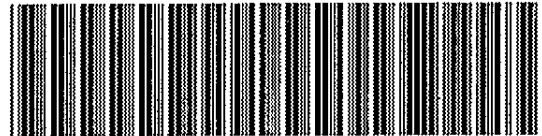



**ARTICLES OF ORGANIZATION  
FOR  
FLORIDA LIMITED LIABILITY COMPANY**

The undersigned person, acting as an organizer of a limited liability company under the Florida Limited Liability Company Statutory Provisions, hereby adopts the following articles of organization:

**ARTICLE I**

1. **Name.** The name of this limited liability company is "**The Tranquil Pirate, LLC.**"

**ARTICLE II - Address:**

A Class B interest can become a Class A interest only upon the terms and conditions set forth in the operating agreement.

**Admission of Additional Members.** Additional members may be admitted only if they are related by blood or marriage to the existing members.




