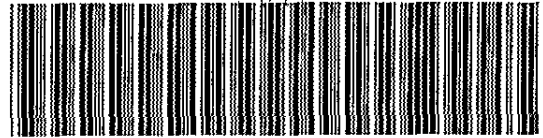

The undersigned, for the purpose of forming a limited liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I — NAME

The name of the limited liability Company shall be 442 & MISSION, LLC ("Company").

ARTICLE II — ADDRESS

The street address and mailing address of the principal office of the Company is 3301 Oak Vista Drive, Daytona Beach, FL 32128

ARTICLE III — DURATION

The Company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date as specified. The Company's existence shall be perpetual unless the Company is dissolved earlier as provided in these articles of organization or in the regulations.

ARTICLE IV — REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the state of Florida is: Richard A. Friedman, 3301 Oak Vista Drive, Daytona Beach, FL 32128

ARTICLE V — ADMISSION OF NEW MEMBERS

Except as set forth in the Operating Agreement, no additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the Operating Agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all of the members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

ARTICLE VI — MEMBERS' RIGHT TO CONTINUE BUSINESS


In the event of the death, withdrawal, retirement, resignation, bankruptcy or dissolution of a member or other event which terminates the continued membership of a member in the Company, the Company shall not be dissolved and the business of the Company shall be continued without interruption.


