## ARTICLE X ADMISSION OF NEW MEMBERS

At the end of such distribution period, the former member, its/his/her heirs, estate, designee or trustee shall be entitled to receive the corresponding percentage of ownership of said member at the ten current value payable in (5) installments. Current value shall be defined by the company's accountants which determination shall also be final.


