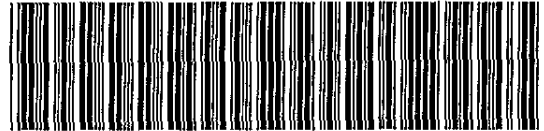

- 2 Timothy L. Kuker


ARTICLE VIII


