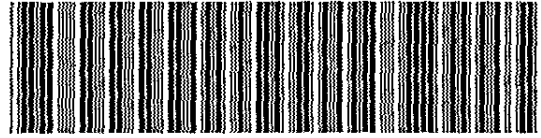




ARTICLE V - MANAGEMENT


