

ARTICLES OF ORGANIZATION FOR A LIMITED LIABILITY COMPANY

The undersigned being authorized to execute and file these articles hereby certifies that:

ARTICLE I - Name

The name of the Limited Liability Company is Edgewater Enterprises, L.L.C

ARTICLE II - Purpose
