ARTICLES OF ORGANIZATION OF Tanthor, L.L.C.

ARTICLE I

Name

The name of the limited liability company ("Company") is Tanthor, L.L.C.

To the fullest extent permitted by the Laws of Florida, as the same may be from time to time amended, but subject to all restrictions set forth therein, the Company shall indemnify, hold harmless, and advance expenses to any person, his or her heirs, personal representative, executor administrator or guardian who was or is a party to any proceeding, as defined in the statutes, by reason of the fact that he or she was a member or manager of the Company, against liability as defined in the Operating Agreement and amounts paid in settlement incurred in connection with such proceeding, including any appeal thereof.
