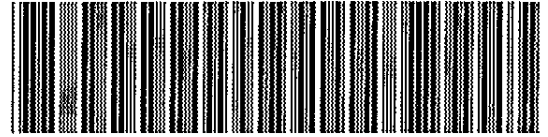




**ARTICLE IV
