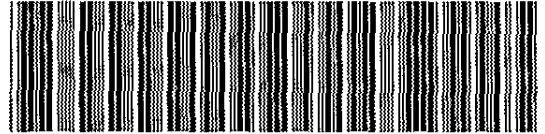

CONTINUATION OF BUSINESS**
