# ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be MR. PRETZELS USA, LLC, ("Company").

# **ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 940 Lincoln Road, Suite 201, Miami Beach, Florida 33139 and the mailing address shall be Post Office Box 330827, Coconut Grove, Florida 33233.

#### **ARTICLE 3 - EFFECTIVE DATE**

These Articles of Organization shall be effective January 2nd, 2003.

# ARTICLE 6 - REGISTERED OFFICE AND REGISTERED AGENT



#### **ARTICLE 10 - INDEMNIFICATION**



All references in these Articles of Organization are deemed to include any amendment or successor thereto. Nothing contained in these Articles of Organization shall limit or preclude the exercise of any right relating to indemnification or advance of attorney fees and expenses to any person who is or was a manager, officer, employee or agent of the Company or the ability of the Company otherwise to indemnify or advance expenses to any such person by contract or in any other manner. If any word, clause or sentence of the foregoing provisions regarding indemnification or advancement of the attorney fees or expenses shall be held invalid as contrary to law or public policy it shall be severable and the provisions remaining shall not be otherwise affected. All references in these Articles of Organization to "manager", "officer", "employee" and "agent" shall include the heirs, estates, executors, administrators and personal representatives of such persons.
