ARTICLE XI - AMENDMENT OF ARTICLES OF ORGANIZATION

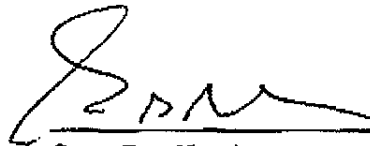
Any amendment to the Articles of Organization shall be approved by all of the membership interests and the Manager and shall be as prescribed by the Secretary of State of the State of Florida.

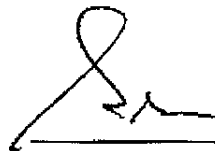
ACCEPTANCE OF REGISTERED AGENT
