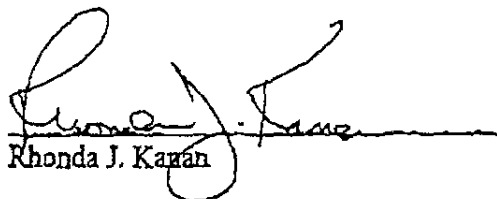
**ARTICLE VII**

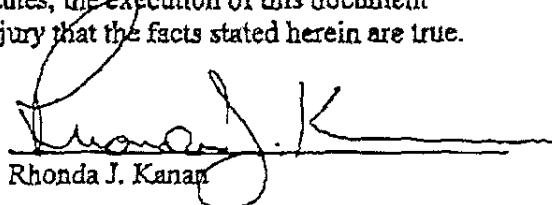
**ARTICLE VIII**

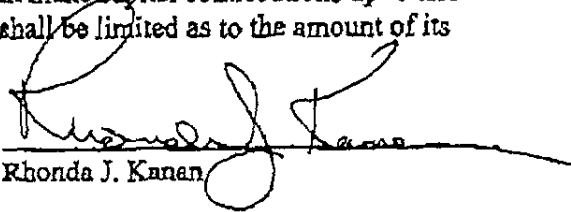

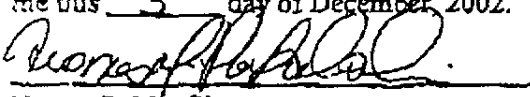
