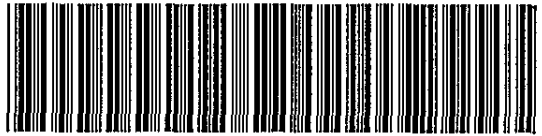



ARTICLES OF ORGANIZATION

OF

4. Place of Business. The mailing and street address of the Company's principal office is 1037 5th Avenue North, Naples, Florida 34102.




