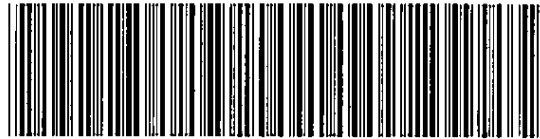

The Articles of Organization for this Limited Liability Company were filed on December 4, 2002, and assigned Florida document number L02000032557.


These Articles of Amendment are submitted to amend the following:
