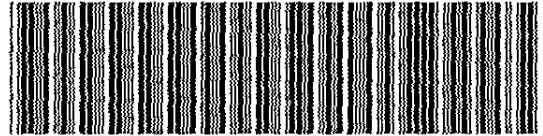

The undersigned individual hereby adopts these Articles of Organization in order to form a limited liability company under Chapter 608, Florida Statutes.

ARTICLE I
NAME

The name of the limited liability company is WLS Enterprises, LLC (the "Company").

ARTICLE II
EXISTENCE AND DURATION

The existence of the Company shall commence on the filing of these Articles of Organization with the Florida Department of State and its existence shall be perpetual unless it is earlier dissolved as provided in these Articles of Organization, its Regulations, or by operation of the Florida Limited Liability Company Act.

ARTICLE III
BUSINESS AND MAILING ADDRESS

ARTICLE IV
REGISTERED OFFICE AND AGENT

ARTICLE V

MANAGEMENT

The Company is to be a manager-managed company and shall have a single manager. ARTICLE VI
