TO
ARTICLES OF ORGANIZATION
OF

Pursuant to Section 608.411 of the Florida Limited Liability Company Act, TONERTYPE, LLC adopts these Articles of Amendment:

FIRST: The name of the limited liability company is Tonertype, LLC.

SECOND: The Articles of Organization were filed on December 6, 2002.

THIRD: Paragraph 1 of the company's Articles of Organization is amended in its entirety to read as follows:
