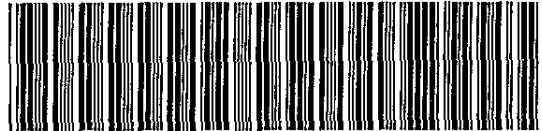

ARTICLE IV


Purpose


