- 2. - 4. The written consent of the Managers of the substitution must be obtained, the denial of which is in the sole, and absolute discretion of the Managers.
- B. Admission of Additional Members. The Managers of this limited liability company have the right to admit additional Members in their sole discretion.
- C. Termination of Membership of a Member. The membership of a Member in this limited liability company may only be terminated upon the occurrence of any of the following events: death, retirement, resignation, expulsion by unanimous consent of the remaining Members of the limited liability company, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a Member of this limited liability company.
