ARTICLE 1

Name

The name of the limited liability company shall be Formatus Investments, LLC

ARTICLE 2

Address

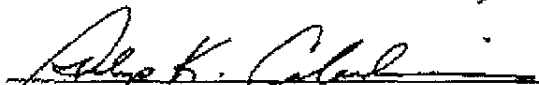
members. A member may transfer or assign membership interest only upon the consent and ratification of all then-existing members of the company.

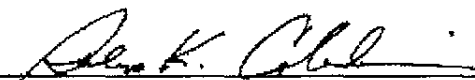
