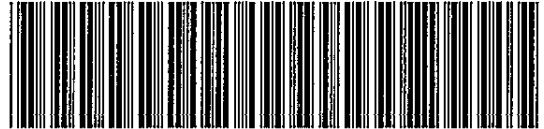

Article VII – Purpose

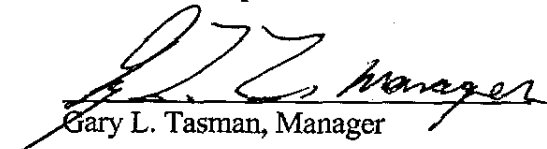
