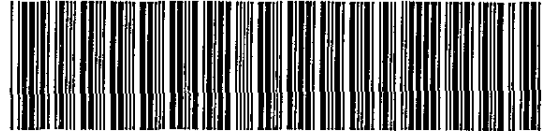

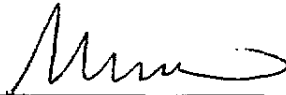
ARTICLE VIII -- MEMBERS' RIGHT TO CONTINUE BUSINESS

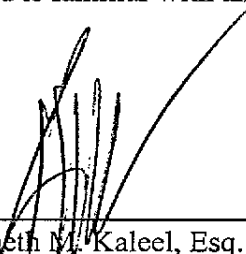
