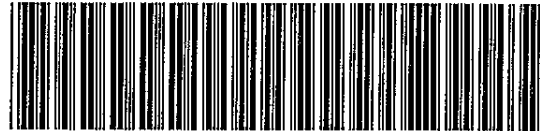

**ARTICLES OF ORGANIZATION OF  
ADCL, LLC**

The undersigned, desiring to form a Limited Liability Company under and pursuant to §608.405, Florida Statutes, does hereby certify as follows:

FIRST: The name of said limited liability company shall be ADCL, LLC.

SECOND: ADCL, LLC shall exist in perpetuity.

THIRD: Copies of the Operating Agreement of ADCL, LLC may be obtained from the Manager at 7994 Royal Birkdale Circle, Bradenton, FL 34202, which is the place in the State of Florida where the principal office of the limited liability company is located. The mailing address of ADCL, LLC shall be 7994 Royal Birkdale Circle, Bradenton, FL 34202.

FOURTH: The purposes for which ADCL, LLC is formed are:

A. Engaging in any and all phases of the business of the business of owning real estate;  
and

B. To engage in such other lawful acts or activities for which limited liability companies may be formed under Section 608.405, Florida Statutes.
