ARTICLES OF ORGANIZATION

OF

CBT DEVELOPMENT GROUP, LLC

Mark Ser Smilion The undersigned, for the purpose of forming a limited liability company under the Flor Limited Liability Company Act F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be CBT DEVELOPMENT GROUP, LLC ("Company"). The principal place of business of the Company in Florida shall be located at 3152 N.W. 30th Way, Boca Raton, FL 33431 and the mailing address shall be the same.

ARTICLE II - DURATION

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least two remaining members.

<u>ARTICLE IX - MANAGEMENT</u>

The Company shall be managed by a manager in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
