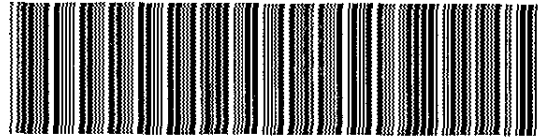

**ARTICLES OF ORGANIZATION

SECOND: The period of duration for the Limited Liability Company shall be perpetual.


THIRD: The Limited Liability Company is organized for the purpose of engaging in the practice of law and to take all actions that are necessary or proper in connection with such services.


