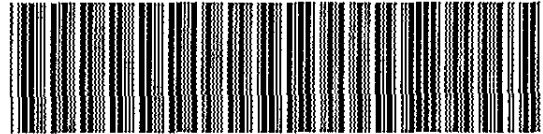

Pursuant to the provisions of Section 608.411 of the Florida Limited Liability Company Act (the "Act"), the undersigned company, **CLEARVIEW OPEN MRI, LLC**, a Florida Limited Liability Company (the "Company"), adopts the following Articles of Amendment (the "Amendment").

1. **First Amendment Adopted:** The Amendment adopted provides for a change in the company name as set forth in Article I of the Articles of Organization, which were filed on December 11, 2002.
2. **Text of Amendment:** Article I of the Articles of Organization is amended by deleting such Article I in its entirety and substituting in lieu of such Article I the following Article I which reads as follows:
