ARTICLES OF ORGANIZATION

OF

INNOVATIVE ORTHODONTIC PRODUCTS, L.L.C.

ON MODE PILED PAINS The members, for the purpose of forming a limited liability company under the Florida Limited Liability Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Innovative Orthodontic Products, L.L.C.

ARTICLE II - DURATION

Innovative Orthodontic Products, L.L.C. (the "Company") shall have perpetual duration.

ARTICLE III - PRINCIPAL PLACE OF BUSINESS AND ADDRESS

ARTICLE VII - ADDITIONAL CAPITAL CONTRIBUTIONS

No additional contributions of cash or property are required to be made to the Company, except as the Members may otherwise unanimously agree upon as provided in the Operating Agreement of the Company to be hereafter adopted by the Members of the Company (the "Operating Agreement").

ARTICLE VIII - ADDITIONAL MEMBERS
