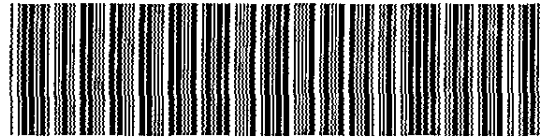

ARTICLE I — Name:



ARTICLE VIII — Registered Agent and Office:




