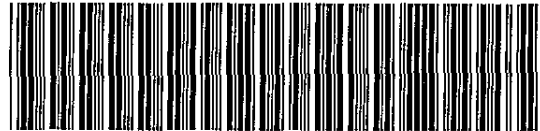

ARTICLES OF ORGANIZATION

OF

KRISHNA OF ORLANDO, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization:

ARTICLE I

NAME OF THE LIMITED LIABILITY COMPANY

The name of this Limited Liability Company shall be **KRISHNA OF ORLANDO, L.L.C.**

ARTICLE II

ADDRESS

The mailing address and street address of the principal office of the Company shall be 1675 Rachels Ridge Loop, Ocoee, Florida 34761.

ARTICLE III

PERIOD OF DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date

ARTICLE IV

REGISTERED OFFICE AND AGENT

The initial street address in Florida of the initial registered office of the Company is **1675 Rachels Ridge Loop, Ocoee, Florida 34761** and the name of the initial registered agent at such address is **JAYESH A. PATEL**.

ARTICLE V

CAPITAL CONTRIBUTIONS

ARTICLE VI

ADDITIONAL CAPITAL CONTRIBUTIONS

ARTICLE VIII

MEMBERS' RIGHT TO CONTINUE BUSINESS

The Company shall be dissolved on the death, bankruptcy or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by unanimous vote of the remaining members.

ARTICLE IX

MANAGEMENT

The Company shall be managed by the members in accordance with Regulations adopted by the members for the management of the business and affairs of the Company. These Regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. 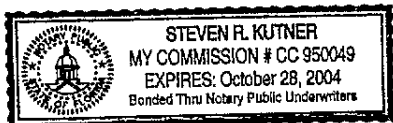
