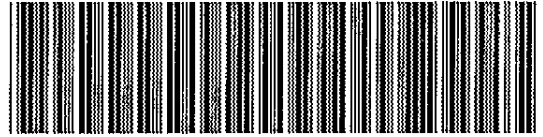

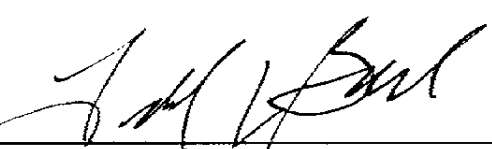

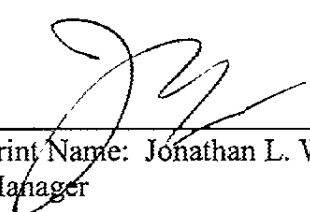
ARTICLE VII-Members' Right to Continue Business:

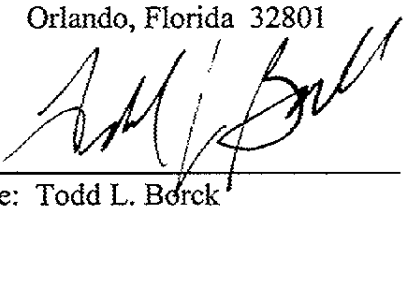

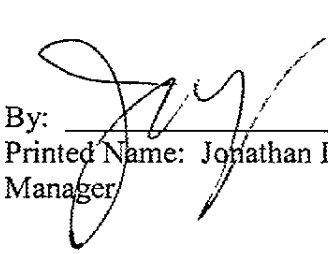

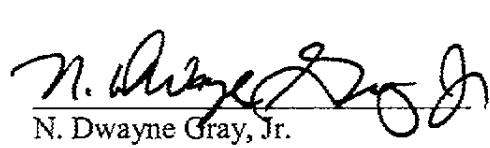
