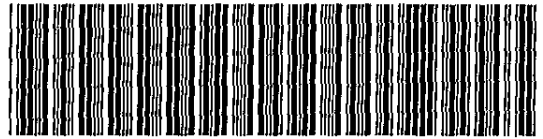

The Limited Liability Company is to be managed by its members and the name and address of the initial managing member is:

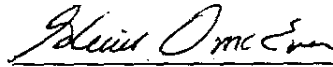

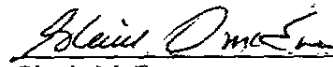
